PRODUCT DESCRIPTION

Advance-line exterior doorset RC3, including glazed reinforced wooden door and frame, and standard hardware for installation. Doorleaf has 77 mm sandwich construction with wood fibre core, and it is installed together as a doorset with the Swedoor-frameset for exterior doors. Product is suitable for use in both private and commercial buildings, with main area of use residential houses (1+2 dwellings). The doorset can be manufactured with classification option for 30 minute fire rating and up to 44 dB sound reduction.

The scope of this EPD is the full doorset for module size of 9x21, depth of frame 210 mm. The reference size of 0,988 m x 2,080 m is used in the LCA to calculate the results for the declared unit (one square meter of the doorset).

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

The manufacturing process begins by gluing and pressing the components of the doorleaf together. This is followed then by different milling phases, where the product components are made to meet the correct dimensions, as well as the holes for the hardware installations and chosen edge profiles and the glazing hole are made. Next, the door undergoes the surface treatment. After the painting process, the

door is ready for installing the glazing and hardware (lock and hinges). Lastly, before leaving the factory, the door is stacked onto pallets along other doors and to shield the finished product during transportation phase, the stack is protected with cardboard and plastic packaging materials

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The transportation distance is calculated based on the product-specific sales data, taking into account the end customer locations; weighted average result is being used. The transportation method is assumed to be lorry and ferry. Vehicle capacity utilization volume factor is assumed to be 1 which means full load. In reality, it may vary but as role of transportation emissions in total results is small, the variety in load is assumed to be negligible. Empty returns are not taken into account as it is assumed that return trip is used by the transportation company to serve the needs of other clients. Transportation does not cause losses as product are packaged properly.

Installation includes the generated packaging waste. There is no loss on site during construction activities. Energy use during installation has not been taken into account, as installing the door only requires mounting and fastening. No additional materials are needed for installation.

PRODUCT USE AND MAINTENANCE (B1-B7)

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

Consumption of energy and natural resources in demolition process is assumed to be negligible.

It is assumed that the waste is collected as mixed construction waste and transported to the waste treatment center. Transportation distance to treatment is assumed as 50 km and the transportation method is assumed to be lorry (C2).


Per the end of life scenario of timber windows and doorsets (EN17213 Annex B), the wood, metal, glass, plastic, paint and glue are sorted. Module C3 accounts for energy and resource inputs for sorting and treating these waste streams for recycling and incineration with energy recovery.

Per the end of life scenario of timber windows and doorsets (EN17213 Annex B), 5% of wood, 5% of metal, 70% of glass, 5% of plastic and 5% of paint and glue waste goes to landfill. Additionally, hazardous waste that is incinerated is included in Module C4 while the flow not included in Module D for benefits.

As specific national data is not used for timber / wooden products, then according to the end of life scenario of timber windows and doorsets (EN17213 Annex B), 100% of sorted timber materials goes to incineration.

The wooden pallet, wooden board, cardboard packaging and plastic packaging used during transportation are also incinerated for energy recovery or recycled. The benefits and loads of incineration and recycling are included in Module D.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product’s manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:
