製品説明 - PRODUCT DESCRIPTION

This is a wood finish material designed for access floors. The surface layer is made of natural wood, creating a natural-feeling design. We offer three wood species: Ash, Oak, and Birch. Using peel-up adhesive, these can be directly applied to access floors and feature the ability to be removed when needed. We've adopted a unique resin groove joining system that absorbs unevenness in access floors. At 6mm thickness—the same as carpet—these panels can be installed side by side without requiring joint strips.

製造と梱包 - MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

This product consists of plywood laminated with decorative wood veneer that undergoes processing and finishing. We source wood materials both

domestically and internationally, which are transported to our factory by truck.

Our manufacturing process involves several key steps: veneer production, cutting, sanding, lamination, processing, and finishing. The decorative veneer is applied to the plywood surface, after which the laminated material is processed and finished to complete the product. Our manufacturing operations require electricity to power various equipment. The product incorporates several auxiliary materials including paints, colorants, and putty. Finished products are packaged in cardboard boxes for shipment.

Wood waste and defective products generated during processing are partially repurposed as fuel for our biomass boiler. Our manufacturing process generates waste consisting of paint and adhesive residues, as well as boiler ash.

輸送と据付 - TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

This EPD excludes the A4-A5 stage. Therefore, packaging wastes are considered in the end-of-life stage.

製品使用とメンテナンス - PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD excludes the use stage.

Air, soil, and water impacts during the use phase have not been studied.

製品の廃棄・リサイクル段階 - PRODUCT END OF LIFE (C1-C4, D)

Energy consumed during demolition of building (C1) is considered negligible in all scenarios. Transportation distance and methods to the treatment facilities (C2) are assumed to be 50km by a truck in all scenarios. In this EPD, end-of-life scenarios are developed for each material categories.

Wooden materials:

At the end of its lifetime, a timber product can have several end of life scenario options.

Because of the uncertainties surrounding waste disposal practices in the future, exact methods of disposal at the end of life is hard to determine. In this EPD, 92.1% of product wastes are assumed to be chipped for the future use as fuel, 6.3% are assumed to be incinerated without energy recovery, and 1.6% are assumed to be landfilled.

The scenario is based on the results of a Survey of construction by-products in 2018 published by the Ministry of Land, Infrastructure and Transport, with the assumption of no material recycled between construction sites.

Paperboard (packaging):

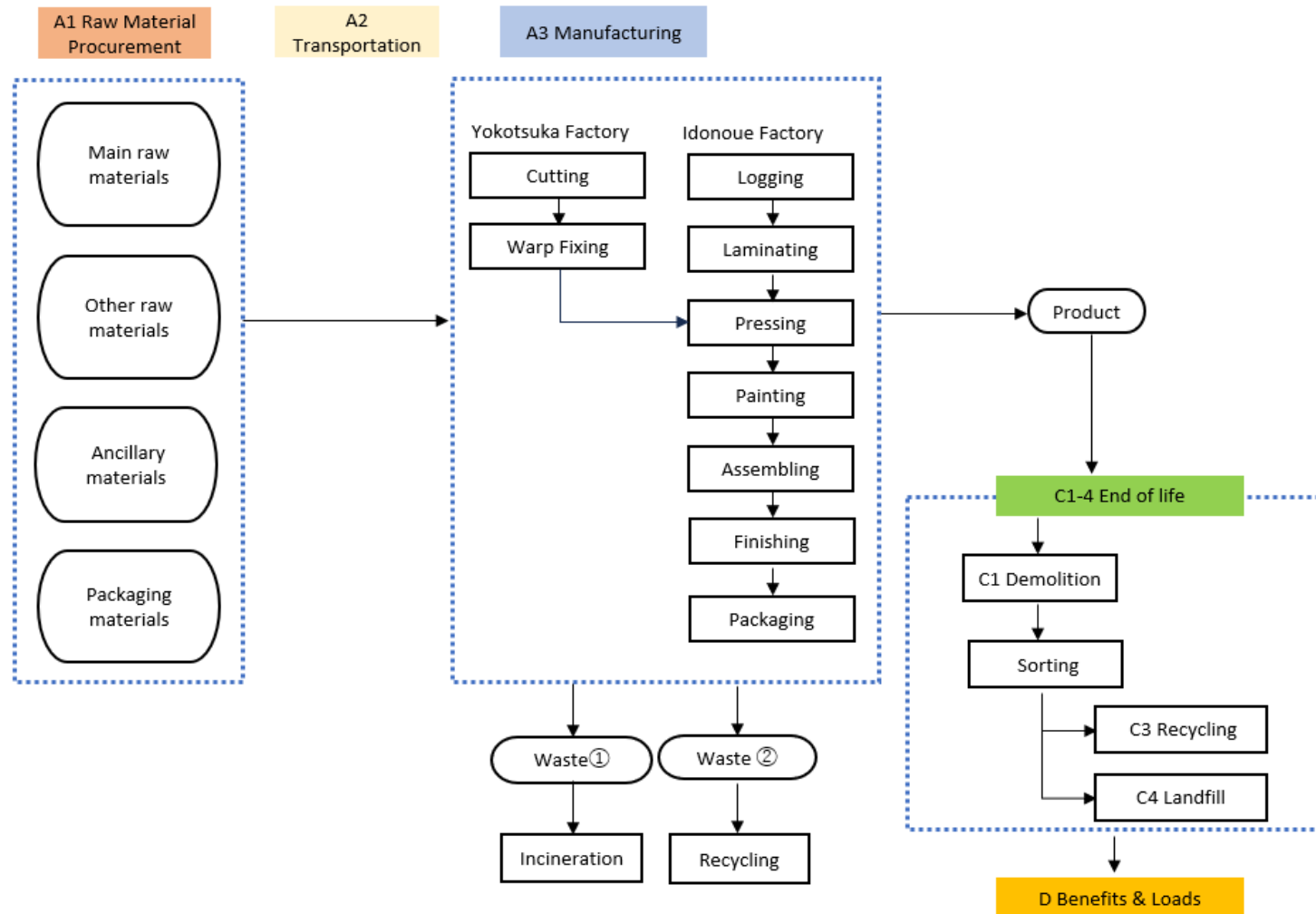
According to the website of Corrugated Packaging Recycling Council, 94.8% of the waste paperboard are collected at proper facilities. Therefore, EOL scenario of paperboard is assumed to be 94.8% recycled and 5.2% incinerated without energy recovery.

PP strapping band (packaging):

The EOL scenario is assumed to be 25% recycled, 57% energy recovery, 10% incinerated and 8% landfilled based on the report published by Ministry of Environment.

Loads of processing for recycling and benefits of avoided virgin PP production and recovered energy are declared in module D.

カットオフ基準 - CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

データの検証 - VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.
