Our single-sided door features a steel plate on the front face only, with hat-channel reinforcements on the reverse side to prevent warping. This design maintains structural integrity while offering lightweight construction and ease of installation. These doors are ideal for utility applications such as meter boxes and pipe access areas. Fire-resistant versions are available, engineered based on comprehensive fire testing. Although our calculations reference standard dimensions (900mm width x 2100mm height), all products can be custom-designed to suit specific applications and opening specifications.

製造と梱包 - MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

Our products are steel doors fabricated from precision-processed steel plates. These plates are sourced from specialized steel trading companies and delivered by truck to our Tsugawa Factory.

The manufacturing process begins with cutting, punching, and bending the steel plates to create individual components. These components are then assembled and welded to form the door structure. The final stages include applying a rust-preventive coating and installing door hardware to complete the product.

Our production facilities utilize electricity and LPG to power various manufacturing equipment. The production process also requires several ancillary materials including paints, adhesives, and welding wire. For shipping, finished doors are protected with wooden battens, cardboard sheets, and polyethylene film to prevent contact damage during transportation.

We maintain environmentally responsible practices by ensuring all steel remnants from the manufacturing process are sent to recycling contractors for reprocessing. Waste materials such as paint and other substances are properly disposed of according to industrial waste regulations.

輸送と据付 - TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions. This EPD excludes the transport (A4) and installation (A5) phase.



The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

データの検証- VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.
