メーカーの概要 - ABOUT THE MANUFACTURER

Our company was founded in 1954 as Seihoku Plywood Industries Co., Ltd. and adopted its current name in 1990. Our headquarters is situated in Hongo, Bunkyo-ku, Tokyo. The Ishinomaki Factory began operations in October 1966 as a thin plywood production facility and has since evolved to specialize in the manufacturing and distribution of long-span structural plywood.

製品説明 - PRODUCT DESCRIPTION

Our company produces JAS-certified structural plywood with the highest formaldehyde emission standards (F☆☆☆☆ rating), utilizing alkaline phenol resin adhesives. We source our raw materials primarily from domestic species including Japanese cedar (Sugi), Japanese red pine (Akamatsu), and Japanese larch (Karamatsu), supplemented with PEFC-certified Canadian timber. Available in thicknesses ranging from 9mm to 30mm, our products are supplied to building material manufacturers, housing companies, and pre-cut facilities, where they serve a variety of structural applications in residential construction, including subflooring, wall sheathing, and roof decking.

製造と梱包 - MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

This product is plywood created by rotary-cutting logs into thin veneers, drying them, then bonding multiple layers with adhesive so that the wood grain of adjacent layers runs approximately perpendicular to each other. The manufacturing process involves peeling, drying, adhesive application, cold pressing, hot pressing, thickness calibration, cutting, inspection, marking, and packaging.

The product stage encompasses all raw materials, ancillary materials, and packaging materials used in production. Steam for hot pressing and veneer drying is generated through our on-site biomass energy system, utilizing bark and veneer off-cuts generated within the facility as fuel.

輸送と据付 - TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

This EPD excludes the A4-A5 stage. Therefore, packaging wastes are considered in the end-of-life stage.

This EPD excludes the use stage.

Air, soil, and water impacts during the use phase have not been studied.

For demolition (C1), it is postulated that 0.00265L/kg of diesel fuel is consumed.

The transport distance and method to processing facilities (C2) is postulated to be 50km by truck for all scenarios.

In this EPD, end-of-life (EOL) scenarios have been developed for each material category.

Wooden waste:

At the end of its lifetime, a timber product can have several end of life scenario options.

Because of the uncertainties surrounding waste disposal practices in the future, exact methods of disposal at the end of life is hard to determine. In this EPD, 92.1% of product wastes are assumed to be chipped for the future use as fuel, 6.3% are assumed to be incinerated without energy recovery, and 1.6% are assumed to be landfilled.

The scenario is based on the results of a Survey of construction by-products in 2018 published by the Ministry of Land, Infrastructure and Transport, with the assumption of no material recycled between construction sites.


As this EPD does not include A5 stage, packaging wastes are considered in the end-of-life stage.

PP strapping band (packaging):

The EOL scenario is assumed to be 25% recycled, 57% energy recovery, 10% incinerated and 8% landfilled based on the report published by Ministry of Environment.

Based on EOL scenarios, the benefits and loads are considered in D for cases where there is recycling, reuse and energy recovery.

カットオフ基準 - CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

データの検証 - VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.
