MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

All required components are sourced from various qualified suppliers. These include powder-coated sheet metal parts, fans, heating coils, insulation materials, and additional auxiliary components.

The manufacturing process begins with the assembly of the sheet metal parts using rivets and selected fasteners to form the complete unit casing. During this stage, acoustic insulation is installed where required, typically secured using spray adhesive.

Subsequently, the fans are mounted and fixed with screws, followed by the installation of heating coils, which are secured using rivets. Electrical installation is then carried out, including placement of plastic conduits and routing of cabling from the motors to the electronic control board, where all connections are completed.

After assembly, each unit undergoes End-of-Line (EOL) testing to verify functionality and ensure compliance with performance requirements. The final stage consists of packaging. The finished units are wrapped in protective plastic bubble wrap and placed into wooden boxes to ensure safe transportation and handling.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The transportation (A4) is calculated to be from Viale della Repubblica 81/A, 20835 Muggiò (MB), Italy where the factory is located to the capitol of Finland, the transportation method is by truck and ferry where the total distance for truck is 1380km and 1100km for ferry. It is assumed that the product is installed by using a hammer drill for half an hour. The recycling percentages for the packaging waste is the following: For wood 32% is

recycled, 30% is incinerated and 38% goes to landfill. For plastic 40% is recycled, 37% is incinerated and 23% goes to landfill.

PRODUCT USE AND MAINTENANCE (B1-B7)

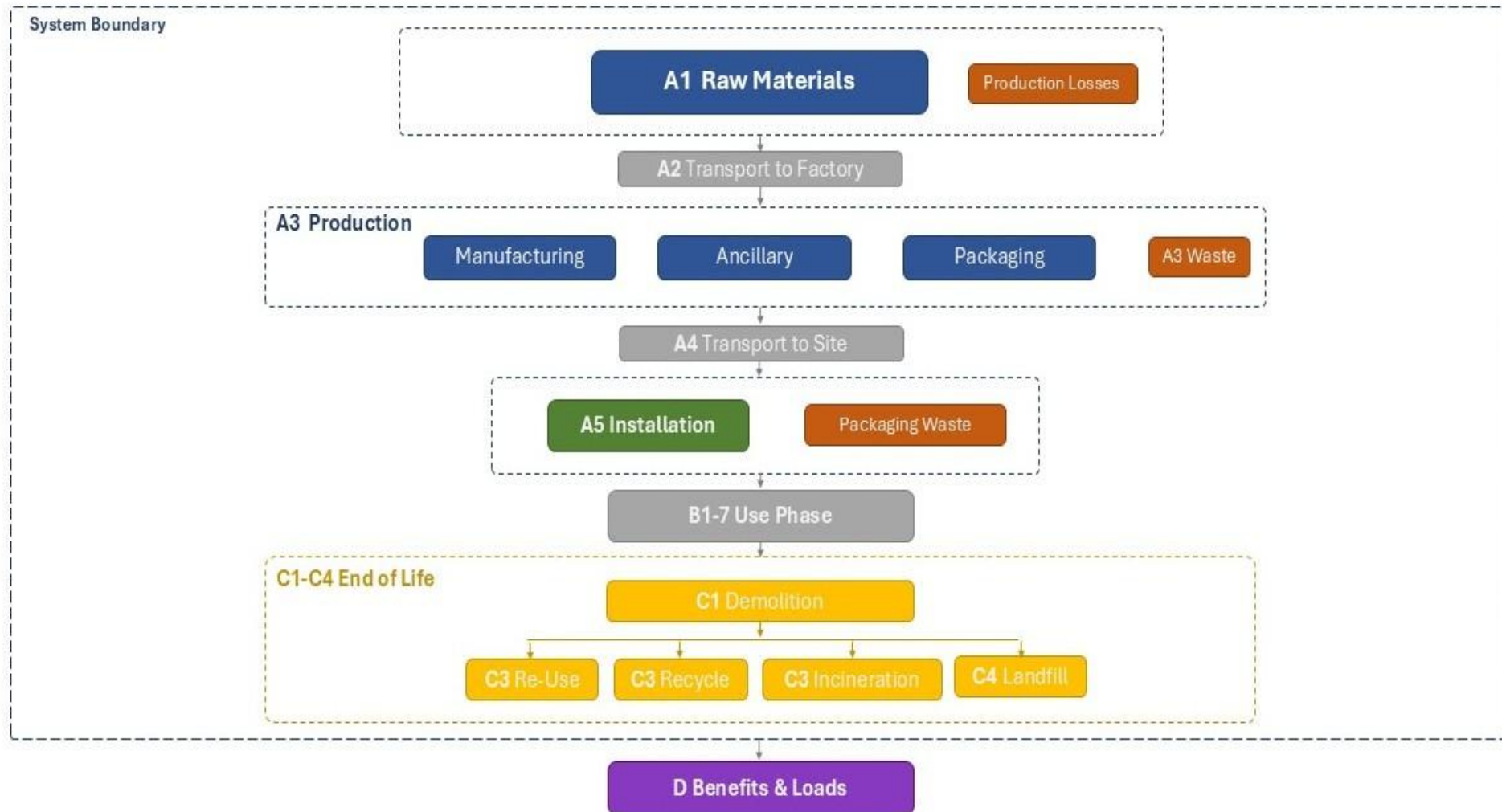
The operational energy use (B6) is calculated based on the required kWh for the fans in the product. The scenario used is 10 working hours per day, where 5 hours is at max speed (5) and 5 hours is at the lowest speed (1). This is calculated based on the lifetime of the unit, this comes out to 928.5 kWh * 15 years = 13927 kWh during its lifetime.

Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

The air curtain is assumed to be dismantled with electrical tools, and these are then transported 50km to the local recycling site by truck (C2). 50km is used because the real-life scenario is unknown and very dependent on which city that the unit is placed in. At the recycling site the product is dismantled into different categories where each raw material is divided into each category such as different kinds of metals and plastics, depending on material the average recovery of material differs. (C3). The remaining that is not recycled is then taken to landfill for disposal (C4). The recycling percentages come from different sources where for steel 85% goes to recycling and 15% goes to landfill. The source used for this is <https://worldsteel.org/wp-content/uploads/Life-cycle-inventory-LCI-study-2020-data-release.pdf>. The aluminium used in the product has a 90% recycling rate and 10% goes to landfill. For the PVC used in the product, 34% goes to recycling, 41% goes to incineration and 25% goes to landfills. For the copper used 60% goes to recycling and 40% goes to landfills. For plastic for instance HDPE 24% goes to recycling, 49% incineration and 27% goes to landfill. The recycled materials are then credited in module D. This is the most likely scenario for the handling of the product at its end of life.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1/3.11/3.12 and One Click LCA databases as sources of environmental data. Allocation used in Ecoinvent 3.10.1/3.11/3.12 environmental data sources follow the methodology 'allocation, Cut-off, EN 15804+A2'.
