メーカーの概要 - ABOUT THE MANUFACTURER

In 1963 (Showa 38), the company was established as Seihoku Plywood Co., Ltd. and began operations with a plywood factory in Koto Ward, Tokyo. In 1988 (Showa 63), it established a coating factory and commenced operations. In 2009 (Heisei 21), the company relocated to Ishinomaki City, Miyagi Prefecture, where it continues to operate to this day.

製品説明 - PRODUCT DESCRIPTION

The products are manufactured using only legally certified domestic softwood. They conform to the Japanese Agricultural Standards (JAS) and comply with the criteria for designated procurement items under Japan's Green Purchasing Act (Law Concerning the Promotion of Procurement of Eco-Friendly Goods and Services by the State and Other Entities). The surface is finished with a polyurethane coating, providing excellent abrasion resistance while preventing curing inhibition of concrete and color transfer during concrete formwork applications. After use, the products can be collected and recycled for use as raw materials in particleboard production or as fuel for biomass power generation.

製造と梱包 - MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

This product is coated formwork plywood featuring surface treatment applied to softwood formwork panels. The product stage encompasses the manufacturing of raw materials, packaging materials, and other ancillary materials used in production.

The manufacturing process involves filling edge surface voids with putty, applying primer sealer, followed by undercoat and topcoat applications, drying, and water repellent spray treatment to the edges.

Our drying operations use steam generated from biomass energy, with fuel sourced from wood chips derived from plywood factory off-cuts, bark, and recycled construction materials.

輸送と据付 - TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

This EPD excludes the A4-A5 stage. Therefore, packaging wastes are considered in the end-of-life stage.

製品使用とメンテナンス - PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD excludes the use stage.

Air, soil, and water impacts during the use phase have not been studied.

製品の廃棄・リサイクル段階 - PRODUCT END OF LIFE (C1-C4, D)

For demolition (C1), it is postulated that 0.00265L/kg of diesel fuel is consumed.

This scenario is based on "Revised New Demolition Work Estimation" issued by the Economic Research Association in April 2017.

The transport distance and method to processing facilities (C2) is postulated to be 50km by truck for all scenarios.

In this EPD, end-of-life (EOL) scenarios have been developed for each material category.

Wooden waste:

At the end of its lifetime, a timber product can have several end of life scenario options.

Because of the uncertainties surrounding waste disposal practices in the future, exact methods of disposal at the end of life is hard to determine. In this EPD, 92.1% of product wastes are assumed to be chipped for the future use as fuel, 6.3% are assumed to be incinerated without energy recovery, and 1.6% are assumed to be landfilled.

The scenario is based on the results of a Survey of construction by-products in 2018 published by the Ministry of Land, Infrastructure and Transport, with the assumption of no material recycled between construction sites.

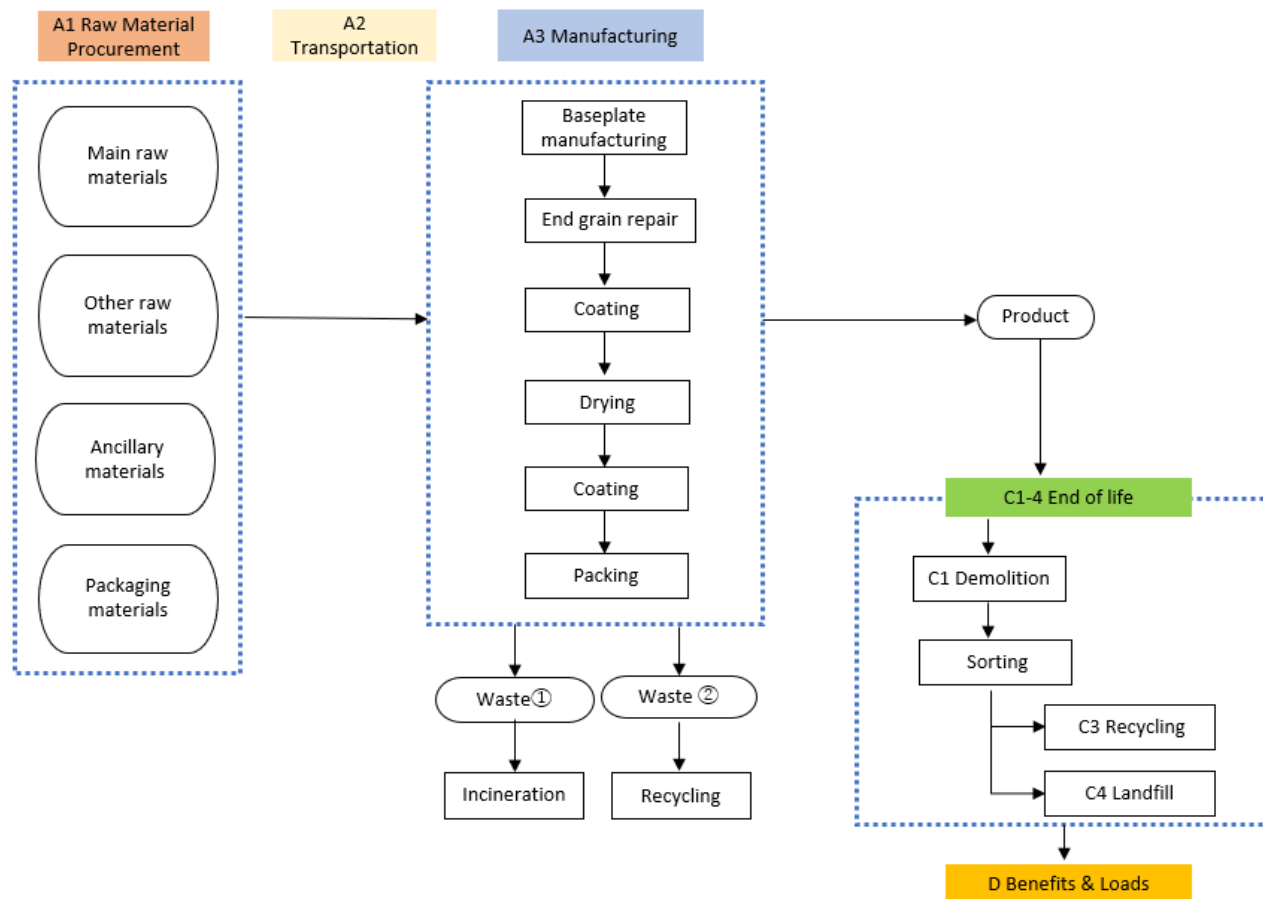
As this EPD does not include A5 stage, packaging wastes are considered in the end-of-life stage.

PP strapping band (packaging):

The EOL scenario is assumed to be 25% recycled, 57% energy recovery, 10% incinerated and 8% landfilled based on the report published by Ministry of Environment.

Based on EOL scenarios, the benefits and loads are considered in D for cases where there is recycling, reuse and energy recovery.

ASSESSMENT

カットオフ基準 - CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

データの検証 - VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.
