メーカーの概要 - ABOUT THE MANUFACTURER

Our company was founded in November 1954 as Seihoku Veneer Industries Co., Ltd. After 1967, plywood manufacturing facilities were established in Ishinomaki City, Miyagi Prefecture. In January 1990, a particleboard factory was constructed as a material recycling facility aimed at the effective utilization of offcuts and veneer cores generated during the plywood manufacturing process. This facility became the first in Japan to commence particleboard production using a continuous press system. The company has continued its operations in this manner to the present day.

製品説明 - PRODUCT DESCRIPTION

The declared products are particleboards conforming to JIS A 5908, the Japanese Industrial Standard specifying the requirements for particleboard, and are available in four main product types: 13REG, 18REG, 13MR1, and 18MR1.

In accordance with the Japanese Building Standards Act and environmental considerations, all products are classified as F☆☆☆☆ low-formaldehyde products.

The products are available in thicknesses ranging from 9 mm to 30 mm. The 13REG and 18REG types are primarily used as substrate boards for decorative surface finishing with decorative sheets and are widely applied in housing equipment components such as system kitchens and storage furniture.

The 13MR1 and 18MR1 types are primarily intended for use as subflooring panels in residential houses and condominiums.

製造と梱包 - MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by

machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission. This product is an engineered wood building material produced by coating wood chips with adhesive and forming them through heat compression.

The manufacturing process follows these steps: cutting, drying, classification, adhesive application, forming, heat compression, curing, sanding, cutting to size, and packaging. The product stage includes the production of all raw materials, packaging materials, and auxiliary materials used in manufacturing.

During the A3 manufacturing stage, purchased electricity, woody biomass fuel, heavy fuel oil, diesel fuel, and industrial water are consumed in the manufacturing process. The finished products are packaged with polypropylene (PP) bands prior to shipment.

輸送と据付 - TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

This EPD excludes the A4-A5 stage. Therefore, packaging wastes are considered in the end-of-life stage.

製品使用とメンテナンス - PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD excludes the use stage. Air, soil, and water impacts during the use phase have not been studied.

製品の廃棄・リサイクル段階 - PRODUCT END OF LIFE (C1-C4, D)

For demolition (C1), it is postulated that 0.00265L/kg of diesel fuel is consumed.

This scenario is based on "Revised New Demolition Work Estimation" issued by the Economic Research Association in April 2017.

The transport distance and method to processing facilities (C2) is postulated to be 50km by truck for all scenarios.

In this EPD, end-of-life (EOL) scenarios have been developed for each material category.

Wooden waste:

At the end of its lifetime, a timber product can have several end of life scenario options.

Because of the uncertainties surrounding waste disposal practices in the future, exact methods of disposal at the end of life is hard to determine. In this EPD, 92.1% of product wastes are assumed to be chipped for the future use as fuel, 6.3% are assumed to be incinerated without energy recovery, and 1.6% are assumed to be landfilled.

The scenario is based on the results of a Survey of construction by-products in 2018 published by the Ministry of Land, Infrastructure and Transport, with the assumption of no material recycled between construction sites.

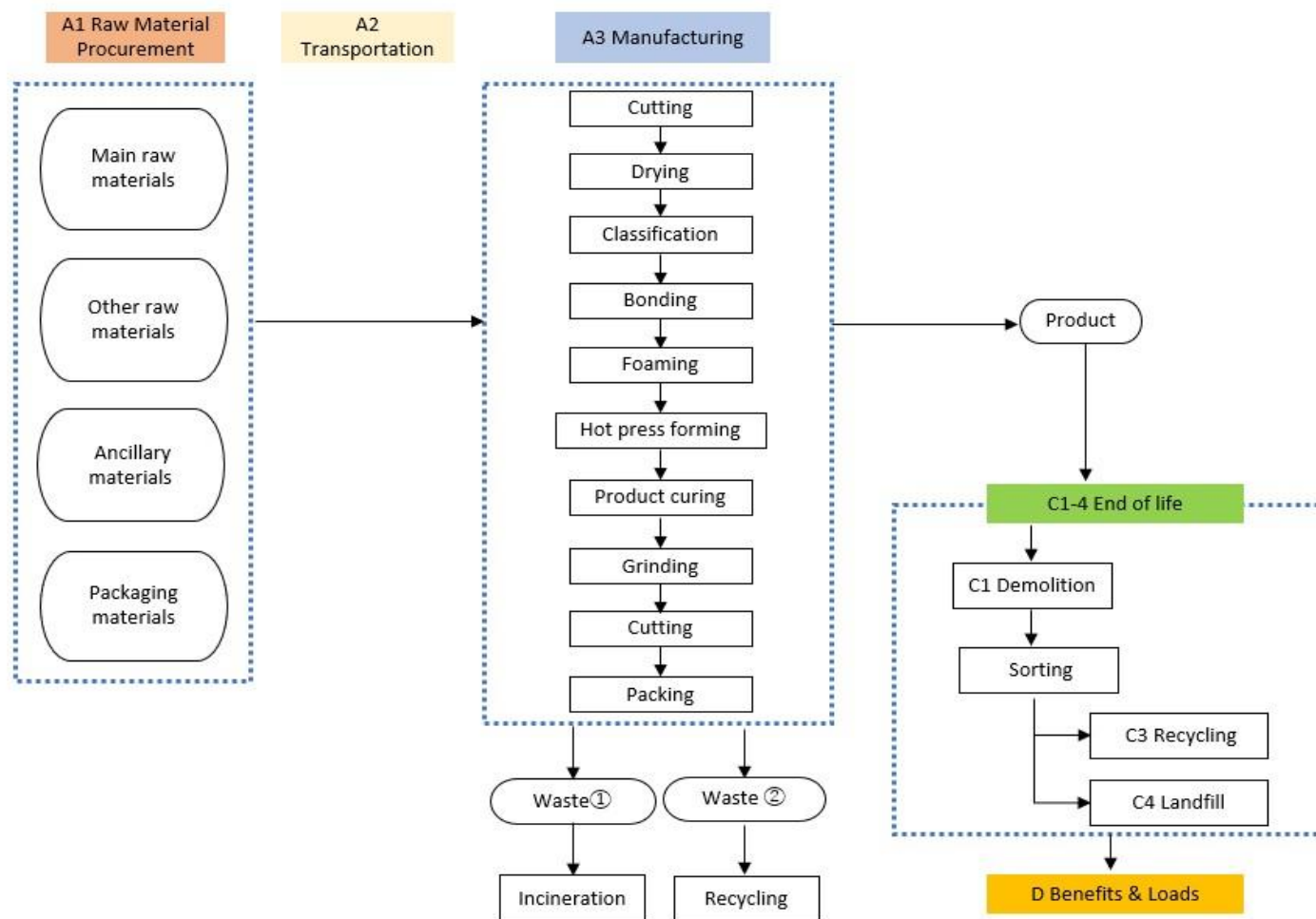
As this EPD does not include A5 stage, packaging wastes are considered in the end-of-life stage.

PP strapping band (packaging):

The EOL scenario is assumed to be 25% recycled, 57% energy recovery, 10% incinerated and 8% landfilled based on the report published by Ministry of Environment.

Based on EOL scenarios, the benefits and loads are considered in D for cases where there is recycling, reuse and energy recovery.

カットオフ基準 - CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

データの検証 - VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.
